**2025 AUGUSTA WOMEN'S TURTLE TOURNAMENT RULES**

1. Handicap will be 90% of difference between highest final 2023-2024 winter year book average and 210 (21 or more games must have been bowled in one sanctioned league). If no 2023-2024 winter season average, entrant shall use the highest USBC sanctioned 2024-2025 winter league average of 21 or more games as of May 31, 2025. Entrants not qualifying under these rules must bowl scratch. Team captains are responsible for getting verification from City Association Secretary of the individual entrant's averages. Verification of averages must be sent with entry, either yearbook or secretary signature with address and phone number.
2. The average of a bowler may be adjusted before the entrant bowls in any event. Bowlers who have bowled in previous Turtle Tournaments (Mixed, Men, or Women's) and bowled 25 or more pins over their entering average must report score bowled for re-rating. Failure to report scores will lead to disqualification. As per Rule 310a-3: It shall be each bowler's responsibility to verify the accuracy of his average whether originally submitted by the bowler, his team captain, or others. Failure to use the proper average or make correction up to the completion of the first game of a series shall disqualify score if submitted average is lower than actual average, or base prize winnings on submitted average if it is higher. Rule 319d will apply - If a bowler who has qualified for a prize of \$300 or more in the previous 12 months in any event he must report actual score, position, and amount won to Tournament Manager for possible re-rating **prior** to start of his entry into tournament. Failure to comply will result in forfeit of fees and winnings.
3. All bowlers must be FEMALE USBC members in good standing. **All bowlers will be required to show their USBC cards at check-in time.** Any bowler who does not show card will be required to pay a participation fee of \$5.00. All PBA members will be limited to two on a four woman team, and one per doubles team.
4. **Those entering singles must enter doubles, and vice-versa.** Singles and doubles will be bowled consecutively without any time break between the events. Singles will be bowled first, then doubles on the same pair of lanes. Singles and doubles will be bowled two or three bowlers per lane. **You are only allowed to enter the singles and doubles event once.** Any bowler caught bowling this event more than once will be disqualified.
5. The four woman team event may be entered twice however, no more than two of the same bowlers may bowl together on the two teams. The first team event rolled will be counted as all events scores.
6. Entry's close midnight July 20, 2025. After an entry has been accepted by the tournament manager, entry fees will not be refunded. The tournament reserves the right to reject any entry and any entry fee. No late entries will be accepted. **Certified checks or money orders only made out to Augusta Women's Turtle Tournament will be accepted, all others will be returned.**
7. Scheduling: Preference in dates and times will be scheduled based on postmark. Shifts will be filled on first come first serve basis. Each entry must indicate at least three different choices of times and dates. If any of the three dates requested are assigned, there will be no changes. Reservations for groups will be held for 30 days only, all advance reservations not received within 30 days will be canceled. Team and doubles line-up will be assigned in order as shown on entry, no changes will be made after entry is entered into computer. Subs must bowl in order of person for which they are bowling. All subs must be checked-in with verification of averages 1 hour prior to squad time. **NO SUBS ALLOWED 30 MINUTES PRIOR TO ANY SHIFT.** If a sub is entered, we will not change back and the person they are bowling for may not sub on another team.
8. Bowlers late for any event will receive a score of zero for each frame missed. All bowlers must be up and ready to bowl when it is their turn, any bowler who delays the progression of the game will receive a score of zero for frames causing delay. **Team captains responsible for informing all teammates to be at lanes 1 hour prior to squad time, informing them of rules, bowling etiquette, and proper attire: NO TANK TOPS, NO SHORT SHORTS, NO HALTER TOPS.**
9. Telescopes will be official score sheet. Said signature will be considered as final approval and only protest of obvious errors in transposing and addition will be considered valid. Any appeals regarding tournament scores must be made in writing to the tournament manager. The action of the tournament manager shall be final unless an appeal is made in writing in accordance with USBC rule 329.
10. Re-bowling Tournament Games or Frames: scores lost due to power failure must be re-bowled. USBC rule 327a.
11. Prize money will be awarded at least 1 prize for each 10 entry's for team, single, and double events, and 1 prize for each 20 entry's for all events. Prize checks will be mailed to team captains, or team coordinators within 30 days after the close of the tournament. **Any changes in Captain/Coordinator must be submitted to tournament manager in writing by current Captain/Coordinator. All checks must be cashed within 60 days or they will not be honored. If a prize check is re-issued for any reason, the stop payment fee charged by the bank will be deducted from the re-issued check.**
12. Premature termination of the tournament brought about by war, national emergency, or emergency causes relating to fire, natural disaster, or any other reason beyond the control of the Augusta Women's Turtle Tournament shall cause, to the extent required thereby, all advertised prizes, guarantees or otherwise to be prorated in accordance with the number of entrants who have bowled in each of the respective events up to the time of such termination.
13. Any rule not covered within shall be governed by USBC RULES.
